- REGISTRATION:** Contestants must register at Marion County Lake prior to the contest on the morning of the event. Parent or adult guardian signature is required at registration.
- LAKE PERMITS:** Contestants 12 years old and older must have a Marion County Lake Permit. Hamilton Bassmasters will pay the cost.
- SAFETY: No Boats Allowed!** Parent or adult guardian must accompany contestant at all times.
- TACKLE AND EQUIPMENT:** Either artificial lures or live bait with only one rod and reel is permitted per contestant.
- FISHING AREA:** Fishing from bank only where permitted by Marion County Lake.
- SCORING:** Final score will be determined by total weight of fish. Only *Bass, Crappie, Catfish, and Bream* are allowed. At the end of the contest, all fish must be brought to the weigh-in in plastic bags provided by *Hamilton Bassmasters*.
